Biographical/Historical Note

The Georgia League of Historical Societies was organized in October, 1967. It was composed of representatives of historical societies and agencies in Georgia. At its meetings, activities of the member organization were discussed and plans for the promotion of history studies were made. It published the *GLHS Newsletter* which contained reports of the activities of the League and its member organizations, and which was distributed to members and non-member subscribers. The Georgia League of Historical Societies ceased to function around 1975.

Scope and Content Note

This collection consists of administrative records for the Georgia League of Historical Societies kept by John W. Bonner, Jr., Treasurer of the League. It includes a treasurer's report from 1968-1970, correspondence, membership lists from 1968-1971, notices of meetings from 1967-1971, completed forms containing information on the member organizations, financial records, the *GLHS Newsletter* from 1969-1970, clippings, and pamphlets regarding the Georgia historical agencies. Also included, as addenda, are the constitution, by-laws, and a program of the Fall 1968 meeting.
