This collection consists of an index labeled "The Travis Abstracts," that records the transfer of property for Savannah City lots, Chatham County lots, and some Effingham County lots. The index is arranged alphabetically by grantor and grantee. The information contained in this index came from records housed at the Chatham County Courthouse and the State Archives in Atlanta (the index cards marked with a "C" are from records in the Georgia State Archives).

The index was microfilmed in Savannah, Georgia in 1965 by the Genealogical Society of Salt Lake City, Utah, and the Department of Archives and History, Atlanta, Georgia.
