Biographical/Historical Note

Morgan County, Georgia, was created in 1807 from land originally in Baldwin County by the state legislature. The town of Madison was incorporated in 1809 and named the county seat.

Scope and Content Note

This collection consists of marriage licenses from Morgan County, 1808-1879, and will books, 1806-1899. Most of the licenses are unbound. The wills include Will Books B, C, and D, 1815-1899. Some of the wills and marriage licenses are indexed.

These records were microfilmed by the Georgia Department of Archives and History in 1971.
