The following maps and architectural drawings are included: map of Chatham County, 1930; map of Happy Discovery, Savannah, Ga., undated; street map of Savannah, 1969; street map of Savannah, 1972, Savannah and Atlanta Railway map, Foundation Tract, Port Wentworth, 1930; map of Jasper County, S.C., 1969; and 2 sets of 5 architectural drawings for the Emanuel Kronstadt House by architect Philip G. Sutker of Savannah, Ga.
